Worldwide inspection and expediting



When carrying out Inspection and Expediting visits on your behalf, depending on progress at the time of the visit, we undertake and report on the following standard activities, which also form the basis of our detailed client reports:

i. Scope of Supply/Order Review

We determine who is involved in the supply chain for your order, and review the details with the supplier, to ensure the same requirements apply to everyone with regard to equipment, spares, special tools, delivery date(s) and so on.

ii. Design & Engineering Review

In instances where design and engineering works are in progress, we review the status of this (rather than the design itself). At all times, our overriding aim is to ensure that the design and engineering progress doesn't cause any unnecessary delays to the project, such as the availability of drawings holding up purchasing or any other activities.

iii. Equipment Installation, Ops and Maintenance Manuals

Depending on the equipment being supplied, we can establish what documentation the supplier is required to provide, as well as the preferred language and format for these.

iv. Purchasing/Procurement Review

We confirm the main purchased items - and the origin of materials used - if restrictions apply. Likewise, we determine purchasing status, to ensure that orders are placed without undue delay. Where items are on longlead time delivery, we also verify that the supplier is expediting their vendors.

v. Free Issue Materials

viii. Surface Protection Review

How the supplier will carry out painting and/or surface protection is also established. In cases where this is already complete, we can also inspect, to confirm it has been done to the required standard.

ix. Quality Control/Testing Review

We review the supplier's internal manufacture records - against an inspection, test plan or their own internal procedures - to ensure they are carrying these out correctly.

x. Packaging Review

We determine how equipment is to be packed, and by whom - supplier or packing sub-contractor. Likewise, we ensure that adequate time has been allocated for equipment packing. Where equipment has already been packaged, this will be inspected to supplier specifications, your exact requirements and our own standards.

xi. Shipping of Hazardous Materials Review

We ascertain if the supplier is shipping any hazardous materials/ dangerous goods. If so, we ensure that any required documentation has been correctly prepared and packaging has been carried out in accordance with the relevant regulations for the destination, as well as any layover countries.

xii. Shipping Arrangements Review

We establish who is responsible - within the supply chain - for shipment, and that its planning is underway. Where the supplier is responsible, we will confirm if they have considered any special shipping requirements, such as escorts, and liaising with utilities companies for oversized shipments - both to the relevant port and your site.
